**BE IT ORDAINED** by the Board of Park Commissioners of the Ford Heights Park District, Cook County, Illinois, as follows:

**Section 1:** That for the purpose of defraying all necessary expenses and liabilities of the Park District for the 2021 tax levy year, a tax for the following sums or so much thereof as by law may be authorized, be and the same is hereby levied against all taxable property in the Park District as assessed and equalized for the year 2021 in the following amounts and for the following purposes, to-wit:

**Section 2:** That said sum of FORTY THOUSAND NINE HUNDRED DOLLARS (\$40,900) is hereby levied and assessed for the above items in the above funds by the Board of Park Commissioners of the Ford Heights Park District.

**Section 3:** The Board Secretary is hereby authorized and directed to file with the County Clerk of Cook County, Illinois, on or before the time required bylaw, a duly certified copy of this Ordinance.

**Section 4:** That if any section, subsection, sentence or item of this Ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portions of this Ordinance.

**Section 5:** This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

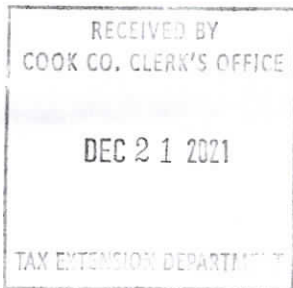


